### **TERMS AND CONDITIONS:**

- No works must be larger than 40" wide, including frame.
- Open to all COAA members in good standing.
- Works must be the original work of the exhibiting artist, and not previously exhibited in the Minto Arts Gallery.
- Works with religious connotations or nudity will not be accepted by the Gallery. The Gallery reserves the right to decline artwork deemed inappropriate.
- All works must be ready to hang in a gallery setting (D-rings & wired)
- All sales are arranged between the purchaser and the Minto Arts Gallery. The Gallery charges 25% commission on sales and does not collect or submit HST.
- No change to title, medium or price permitted after submission.
- The Gallery has a policy of property damage insurance against loss or damage for the insured value of the exhibit in its entirety. Artists are encouraged to make provisions for their own additional insurance.
- Minto Arts Gallery has the right to photograph any work for publicity and website purposes.

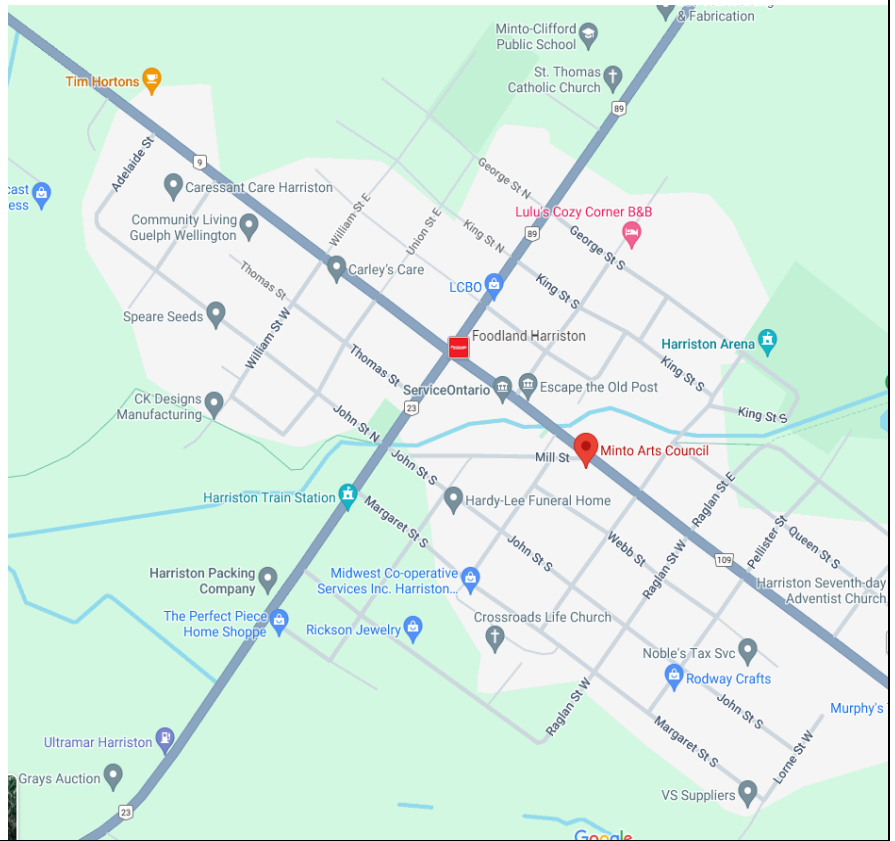
